B. Procedure for online submission of Application Forms

1. BCA / BCA(Hons.) / M.Sc.(CS) / M.Sc. (IT) / PGDCA

The applications should be submitted online through: <http://davv.mponline.gov.in>. A candidate should select **Admission Form Non-CET (2020-21)**. The online application fee is Rs. 750/- (Rs. 400/- for SC/ST candidates of M.P. domicile) per programme. If an applicant wishes to be considered for more than one programme, he/she must apply in separate application form for each programme. Payment of application fee can be done online through Debit card/ Credit card or Net Banking. The admission will be given purely on the basis of merit in the qualifying examination. Graduates, whose final year/semester result is awaited, can also apply on the basis of their result of previous year/ semester. The candidates awaiting their results of qualifying examination and have been admitted provisionally, will have to submit the final mark-sheet of qualifying examination by 30th September 2020 or by the date as notified by Government of Madhya Pradesh.

2. MCA Programme

Admission is through Directorate of Technical Education (DTE).

3. M.Tech Programme

The applications should be submitted through <https://davv.mponline.gov.in>. A candidate should select **ME/MTech/MPharm Admission 2020**. Application fee for each group of programmes is Rs.1000/- (Rs. 600/- for SC/ST of M.P. domicile) only.

Group C: M.Tech(CS)/ M.Tech(NM & IS)/ M.Tech(IA & SE) Full Time Programmes

Admission shall be made on a merit list developed on the basis of GATE score for each programme. However, in case of non availability of GATE qualified candidates, admission will be made on the basis of a merit list developed for each programme considering average marks / CGPA upto seventh semester (B.E./ B.Tech.)/ fifth semester (M.C.A.) /third semester (M.Sc.).

Group D: M.Tech (CS) Executive Programme

Admission shall be made as per merit list developed on the basis of 80% of qualifying examination and 20% of service experience. The candidates must have minimum two years of working experience after qualifying degree.

M. Sc. (IT)	B.C.A./B.Sc.(Hons)/B.Sc.(Computer Science /Electronics/Physics/Information Technology /Electronics and Tele-communication) with 50 % marks and Mathematics as one of the compulsory subjects.
MBA (CM)	Graduation in any stream with 50%.
BCA/ BCA (Hons.)	12 th with 50% marks and Mathematics as one of the compulsory subject.
PGDCA	Bachelor Degree in any stream with min. 50% marks.
M.Tech. (CS) M.Tech (NM & IS) M.Tech (IA & SE)	At least 55% aggregate marks in B.E. / B.Tech. or equivalent in Computer Science, Computer Engineering, Information Technology/ Electronics, Electronics & Communication, Electronics & Instrumentation, Electronics & Electrical or M.Sc.(Computer Science, Information Technology, Electronics, Electronics & Communication), or MCA or Equivalent.
M.Tech. (CS) Executive	55% B.E. / B.Tech. or equivalent in Computer Science, Computer Engineering, Information Technology/ Electronics, Electronics & Communication, Electronics & Instrumentation, Electronics & Electrical or M.Sc. (Computer Science, Information Technology, Electronics, Electronics & Communication) or MCA or Equivalent. The candidates must have minimum two years of working experience after qualifying degree.
