Guidelines for Counseling

Registration Process:

1. Online counseling for groups A, B, and C will be done on the basis of merit. Merit will be generated as per following:

For Group A:

Merit will be prepared on the basis of percentage of marks obtained in 10th, 12th board and graduation; 15 percent proportion will be allocated to 10th board percentage, 20 percent proportion will be allocated to 12th board percentage, and 65 percent proportion will be allocated to graduation percentage.

For example: If a student secures 80 percent marks in 10th board, 90 percent marks in 12th board, and 70% in graduation, the percentages considered for his/her merit will be calculated in following manner:

$$(80*0.15=12.00)+(90*0.20=18.00)+(70*0.65=45.50)=12.00+18.00+45.50=75.50.$$

For Group B and C:

Merit will be prepared on the basis of percentage of marks obtained in 10th and 12th board examinations; 35percentproportionwill be allocated to 10th board percentage and 65 percent proportion will be allocated to 12th board percentage.

For example: If a student secures 80 percent marks in 10^{th} board and 90 percent marks in 12^{th} board, the percentages considered for his/her merit will calculated in following manner: (80*0.35=28.00)+(90*0.65=58.50)=28.00+58.50=86.50.

- 2. Only the candidates who have applied for admission in A, B and C groups (CAP-2020) will be eligible for registration.
- 3. Candidates who wish to appear in online counseling process must register themselves and fill the choice of program(s) through www.davv.mponline.gov.in (Portal charges will be Rs. 100/-) through application ID provided at the time of CAP-2020 registration.

- 4. Registration and choice filling process will start from 20/09/2020 and remain open till 24.09.2020.
- 5. Seats reserved for SC/ST/OBC and EWS categories will be offered to the SC/ST/OBC and EWS candidates of Madhya Pradesh domicile only. SC/ ST/OBC and EWS candidates from other states will be treated under unreserved category. Change of category shall not be accepted at any stage. To avail benefit of reservation a certificate from a Competent Authority should be produced.
- 6. Candidates who will be admitted on undertaking will have to produce final result (in case of result not declared at the time of counseling/ ATKT / Compartment) by 30th October 2020 or any other date decided by the University else admission will automatically be cancelled.
- 7. In case of Tie (more than one student on the same merit percentage) on the merit percentage, merit will be generated as under:

For UG Programs:

- (a) Higher percentage of marks in the qualifying examinations will be considered.
- (b) If the percentage of marks in qualifying examination is also a tie, seniority in age will be considered.
- (c) If the age is also same, then percentage of 10th will be considered.

For PG Programs:

- (a) Higher percentage of marks in the qualifying examinations will be considered.
- (b) If the percentage of marks in qualifying examination is also a tie, seniority in age will be considered.
- (c) If the age is also same, then percentage of 12th will be considered.

Other Important Points

a. Any situation, not covered by provisions mentioned in this guideline shall be referred to the Organizing Committee / Admission Cell which will work within the ambit of Act, Statutes and Ordinances of Devi Ahilya Vishwavidyalaya, Indore and its decision shall be final.

- b. The legal disputes, if any, shall be settled within the jurisdiction of Indore.
- c. In case it comes to the notice that an applicant was able to secure admission based on forged certificate/s or by furnishing wrong information, willingly concealing adverse facts or due to administrative or official negligence, his/her admission will be cancelled immediately without giving any notice.

Reservation Policy and Conversion of Seats

- a. Reservation of seats in programs offered by the University will be in accordance with the policy of Madhya Pradesh Government. The benefit of reservation will be available, **only** to the **domiciles of Madhya Pradesh.**
- b. Of the total seats, 16 percent and 20 percent seats in programs will be reserved for applicants belonging to Scheduled Caste (SC) and Scheduled Tribes (ST), respectively. Seats of both these categories are interchangeable.
- **c.** Of the total seats in a program, 14 percent seats will be reserved for applicants from OBC category (non- creamy layer).
- d. "Reservation for Economical weaker section (EWS) candidates of Madhya Pradesh" will be as per the Government of Madhya Pradesh GAD Letter No. एफ -07-11/2019/आ.प्र./एकभोपाल, Dated 02 July 2019. Ten Percent (10 %) Seats of approved intake will be available for admission for economically weaker section (EWS) candidates of Madhya Pradesh. A candidate claiming for Economical weaker section (EWS) Seat shall have to produce a certificate from the competent authority in **Proform**a given at the end of the document.
- d. Reservation for Persons with disabilities (Physically Challenged (PH) Seats): One seat on over and above basis in each program will be reserved for the physically challenged candidates with disability percentage of 50 or above. Candidates claiming admission against these seats shall be required to produce Disability Certificate from the concerned District Medical Board.
- e. A horizontal reservation of 30 percent of the total seats will be for female applicants.

f. Vacant non-resident Indian seats i.e. unfilled non-resident Indian seats shall be merged into Unreserved open seats.

Counseling process

Online counseling will be conducted on the basis of broad guidelines of Directorate of Technical Education (DTE), M.P. and its Lookup order for allotment.

Counseling for NRI / NRI sponsored and DAVV Employee ward seats

- a. Admission on NRI seats shall be done by the University in offline mode, as per date and time given in the schedule for registered candidates.
- b. DAVV Employee ward quota: Admission on Employee ward seats shall be done by the University in offline mode as per date and time given in the schedule for registered candidates.

First Round of online Counseling

In the first round of counseling, first candidates of reserved categories shall be called in the following order, so that vacant reserved seats can be mutually converted:-

Scheduled Tribes, Scheduled Castes, Scheduled Tribes, Other Backward Classes, Scheduled Tribes/Scheduled Castes.

After conducting counseling of reserved category candidates, as per above order, vacant seats, if any, shall be merged into the unreserved seats and then counselling for unreserved seats shall be conducted.

Candidates of reserved category who find place in the merit list of unreserved category will also be considered in the allotment of seats under unreserved category. They will be given seat of their preference from reserved or unreserved category in which they are getting better choice. Such candidates of reserved category who are allotted seats from unreserved category shall be counted in the unreserved category. The vacant seats of EWS category shall be merged into the unreserved seats.

After allotment, a candidate has to accept the allotted program or opt for up-gradation using his / her application ID. If, a candidate is willing to take admission in allotted program he / she has to upload documents online for the verification. Concerned SOS will verify the documents. The

candidate will be provisionally admitted in the program subject to online submission of fee. Candidate has to submit required fee within the time period given in the counseling schedule failing which his / her allotment will be cancelled.

Upgrade round of Counseling

Upgrade round will be done after first round of counseling against vacant seats on the basis of choices already filled by the candidate.

After upgrade the similar process as mentioned above will be followed for document upload, verification and fee deposit.

Second Round of Online Counseling

Candidates who have not registered for first round of counseling may register for second round of counseling and fill the choices of programs. Candidates who have registered for first round of counseling have to fill the choices of program again for the second round of counseling.

During the second round of online counseling the vacant reserved seats can be mutually Converted as per following order:-

Scheduled Tribes, Scheduled Castes, Scheduled Tribes, Other Backward Classes, Scheduled Tribes/Scheduled Castes.

Also conducting counseling of reserved category candidates, as per above order, vacant seats, if any, shall be merged into the unreserved seats and the counseling for unreserved seats shall be conducted. The vacant seats of EWS category shall be merged into the unreserved seats.

After allotment, If, candidate is willing to take admission in allotted program he / she has to upload documents online for the verification, after verification, if concerned department founds that his / her documents are correct, department will initiate the online link for fees submission. Candidate has to submit required fees within the time period given in the counseling schedule failing which his / her allotment will be cancelled.

Final round of counseling

Last round of counseling of registered candidates against vacant seats if any, will be done at concerned SOS level. The detail process will be announced after second round of counseling.
