The Executive Council of the university in its meeting held on 06.11.2007 has considered and approved the recommendations made by the selection committee in the subject of School of Law (Self Finance)

In accordance with the approval of E.C. the following Candidates are hereby appointed in the post mentioned against their names:-

The terms and condition for the above appointment are as follows:-

1. In addition to approved pay scales, the incumbent shall be entitled for D.A. and other allowances time to time as per university rules
2. The appointment shall be w.e.f. the date of joining
3. The appointment shall be initially on a probation for two years and the university may extend it for one more year.
4. The services may be terminated at any time without prior notice.
5. The appointment shall be governed under the rules mentioned in the Statute No.31. In addition, after joining the university, the revised rules adopted time to time shall be applicable on the incumbent. The conduct rules applicable on the university teachers shall be binding on incumbent.
6. The incumbent has to submit the medical certificate of fitness within seven days of joining the university. This certificate shall be issued by a Government doctor having rank no less than a Civil Surgeon.
7. The Incumbent has to join the duties within one month and the joining letter must be submitted to the Head of the UTD where incumbent has been appointed. In case, he/she is unable to join within a month, it shall be assumed and this appointment order shall be treated as cancelled.
8. In case, the incumbent is coming from a Government Department or Institute, he/she shall be allowed to join the university after getting relieved from the department/institute for which the relieving letter must be submitted at the time of joining.
9. The services of the appointed person shall only be for the self-financing Institute/program where appointed
10. The salary and allowances shall be payable from budget allocated on the income collected by the self-financing institutes/programs of the University. No grant from the University/Government is available for the Salary.
11. The services shall be terminated on the close of self-financing Institute / programs under the defined exit policy of the University.
12. The teachers have to produce an undertaking in this regard (to accept all terms & conditions) on a non-judicial stamp paper of Rs.50/-. The format of affidavit is available at UTD or Registrar Office.



- 2/ The contract appointment is initially for six months which is further extendable but in no case beyond three years or beyond the appointment on regular position of the School or Institute, whichever is earlier.
- 3/ The person so appointed shall have no claim for regularization, absorption and other benefits which are applicable to the regular employees or Teacher. An undertaking to this effect is to be furnished by the Contract Teacher at the time of Joining.
- 4/ The services of the person(s) engaged on contract basis are liable to be terminated at any time without giving any notice.
- 5/ The person(s) appointed on contractual basis will not engage directly or indirectly in any other occupation or institution without prior permission of the authorities of the University. He/ she will not be entitled for salary for the period of absence.
- 6/ The person(s) so appointed will be working full time as required by the Head/Director. However, they must be available in their Department daily atleast for 7 hrs. and for duties assigned to them by concerned HOD.
- 7/ The Salary of the above person(s) will be charged against the School of Law and payment shall be made by the concerned School/Institute.
- 8/ At the time of joining they will produce a fitness certificate from medical officer submitted their academic and experience certificates in original for verification to the concerned School/Institute.
- 9/ One day casual leave will be admissible on completion of one month duty.
- 10/ The appointee should report herself/himself for duty to the Respective Head DAVV, Indore within fifteen days from the issue of this order, failing which this order shall be deemed to be have been cancelled.
