//ORDER//

The Executive Council at its meeting held on 27.11.2004 & 15.12.04 considered the recommendations of the selection committee and has approved the appointment of Dr. Tushar Banerjee on the post of Lecturer in Industrial Microbiology(Life Science) in the scale of Rs. 8000-13500/- on a starting salary of Rs.9100/-. (As per decision of the Selection committee) he will be entitled to D.A. and other allowances as per rates fixed by the university from time to time.

- 2/ The appointment will take effect from the date of joining.
- 3/ The appointment is on probation for a period of two years in the first instance which may be extended for a further period of 12 months for valid reasons.
- 4/ The appointment will be subject to the term and conditions contained in statute No.31, Ordinance No.4 and the rules of revised pay scales. The appointment will further be subject to terms and conditions as specified in the agreement of service and such other rules as may be framed/amended/adopted by the university from time to time.
- 5/ He will have an option at the time of initial appointment of the University service either to elect to join the employees contributory provident fund scheme (Scheme 'A') or pension and Gratuity Scheme (B). The option exercised shall be final and binding. The option should be exercised in quadruplicate in the enclosed from within one month from the date of joining the post.
- 6/ He will have to submit a Certificate of health and physical fitness from the Government Medical Officer (Not below the rank of civil Surgeon) at the time of joining or within seven days thereafter positively.
- 7/ He should report himself for duty to the Respective Head of Department, DAVV Indore within one month of the issue of this order, failing which this order shall be deemed to have been cancelled.

- 8/ Person coming from Government Department/ Institutions should bring relieving letter from their present employer and should submit the same at the time of joining. In the absence of this document/ Certificate he will not be permitted to join the post.
- 9/ The expenditure on the pay and allowance of the above incumbent shall be debited to post of Assistant Librarian, Library Department.


