They will be entitled to D.A. and other allowances as per rates fixed by the University from time to time.

2/ The appointment will take effect from the date they join.

3/ The appointment is on probation for a period of two years in the first instance which may be extended for a further period of 12 months for valid reasons.

4/ The appointment Sr.No. 5,6,10 and 13 is purely on temporary basis and is liable to termination on giving one month notice by either side.

5/ The appointment will be subject to the terms and conditions contained in Statute

No 31 Ordinance No, 4 and the rules of revised pay scales. The appointment will further be subject to terms and conditions as specified in the agreement of service and such other rules as may be framed/am ended /adopted by the University from time to time.


6/ The teacher will have an option at the time of their initial appointment to the University Service either to elect to join the Employees Contributory Provident Fund Scheme (Scheme 'A') or pension and Gratuity Scheme (Scheme 'B'). The option exercised by the teacher shall be final and binding. The option should be exercised in quadruplicate in the enclosed form within one month from the date of joining the post.

7/ They will have to submit a certificate of health and Physical fitness from a Government Medical Officer (not below the rank of Assistant Surgeon) at the time of joining or within seven days thereafter positively.

8/ They should report themselves for duty to the respective Head of the University School of Studies or Kulapati as the case may be, as soon as possible but not later than 22/1/2000.

9/ Persons coming from Govt.Deptts/Institutions should bring relieving letter from their present employer and should submit the same at the time of joining. In the absence of this document/certificate they will not be permitted to join the post.

10/ The expenditure on the pay and allowances of the above incumbents will be debited to the respective budget Head.
