In continuation to this Ministry's Administrative Sanction-cum-Guidelines No. 253/16/2017-BIOGAS dated 30.05.2018 for the implementation of Central Sector Scheme, NNBOMP and extension of the Ongoing NNBOMP up to 31.03.2021 vide Letter No.253/16/2017-BIOGAS,dated 11/06/2020 and MNRE Order No 256/4/2020-BIOGASdated 06.08.2020, the undersigned is directed to convey the sanction of the President under Rule 18 of the Delegation of Financial Powers Rules, 1978, for allocation for a total amount of ₹ 1,82,07,968/- Sanction of the President is also conveyed for release of ₹ 91,03,984/- (Rupees Ninety One Lakh Three Thousand and Nine Hundred Eighty four only) as first instalment for 4 BDTCs for the current year 2020-21 under NNBOMP on the same terms and condition laid down in the Administrative Approval No. 253/16/2017-BIOGAS dated 30.05.2018 and 11.06.2020 to 8 BDTCs, for implementation of the activities under Biogas Programme of this Ministry during 2020-21. The detailed activities to be conducted by BDTCs for each BDTC have been communicated with this Ministry's order No 256/4/2020-BIOGAS dated 06.08.2020.

All BDTCs are advised to restrict their expenditure within the said outlay under the respective heads. It is clarified that expenditure over and above the outlay, if any, will not be reimbursed by this Ministry. Further release will be subject to review of progress and satisfactory performance and submission of UCs for the year 2019-20.

4. The Drawing & Disbursing Officer may prepare the bills for each BDTC towards release of CFA as per the details given below amounting to ₹ 91,03,984/- (Rupees Ninety One Lakh Three Thousand and Nine Hundred Eighty four only) and send the same to PAO, MNRE who would disburse the amount to 4 BDTCs through e-transfer as per details given in table below:

5. The trainings will be conducted in consultation with the implementing agencies/related stakeholders implementing NNBOMP in respective states allocated to each BDTC as per the NNBOMP Guidelines dated 30.05.2018 and extension of Scheme of NNBOMO vide Letter No. 253/16/2017-BIOGAS, dated 11/06/2020. The BDTCs will also bring out technical booklets on Biogas Plants and

success stories and work actively for effective promotion of biogas including technology development by way of increasing efficiency improvements, cost reduction by development of new designs of biogas plant being disseminated under NNBOMP or to be inducted in future implementation and maintain optimal level of functionality of biogas plants. The BDTCs will submit progress reports with complete details of all activities as assigned by MNRE including various training courses.

- 6. All the terms & conditions mentioned in the Administrative approval vide this Ministry's letter No. 253/16/2017-BIOGAS dated 30.05.2018 and dated 11.06.2020 should be followed. Copy of Utilization Certificate for the previous releases is enclosed. The organization comes under Category "A".
- 7. In terms of Rule 230 (7) of GFR 2017 and instructions of DoE the Programme Implementing Agency shall record the receipt of grant and the expenditure therefrom in the EAT module of PFMS.
- 8. In terms of Rule 230 (1) of GFR, the grantee organization/institute will certify that it has not obtained or applied for grants for the same purpose or activity from other Ministry or Department of the Government of India or State Government.
- 8. In terms of provisions contained in Rule 236(i) of GFR, 2017, the account of the grantee organization shall be open to inspection by the sanctioning authority and audit (both by C&AG of India and Internal Audit by the Principal Accounts office of the MNRE), wherever the organization is called upon to do so.
- 9.
