

ORDINANCE NO. 69

1. DEGREE TITLE : MASTER OF TECHNOLOGY in ENERGY MANAGEMENT

M.Tech. (ENERGY MANAGEMENT)

2. NAME OF FACULTY : FACULTY OF ENGINEERING SCIENCES.

3. DURATION OF COURSE : THREE SEMESTERS (FULL TIME) SIX SEMESTERS (MODULAR COURSE)

4. ELIGIBILITY :

(i) B.E./B.Tech. / M.Sc. (Physics) with minimum 55% marks from DEVI AHILYA VISHWAVIDYALAYA or any University recognized by DEVI AHILYA VISHWAVIDYALAYA.

(ii) GATE qualified candidates with qualifications as mentioned under (i).

OR

Teachers from Science Colleges/ Engineering Colleges/Polytechnics and Engineering/ overseers from Industry/Consultancy Organisation/Organisation working in the field of Energy and Environment with qualifications as mentioned under (i).

5. ADMISSION PROCEDURE :

As decided by DEVI AHILYA VISHWAVIDYALAYA from time to time.

6. TOTAL SEATS :

As per Statute 27 DEVI AHILYA VISHWAVIDYALAYA /AICTE.

7. FEE STRUCTURE :

As decided by DEVI AHILYA VISHWAVIDYALAYA or State Government from time to time.

8. EXAMINATION, CURRICULUM & RELATED REGULATIONS :

As per Ordinance 31 of DEVI AHILYA VISHWAVIDYALAYA.

9. ELIGIBILITY FOR DEGREE :

A candidate shall be eligible for the degree of MASTER OF TECHNOLOGY in ENERGY MANAGEMENT when he/she has completed the requirements of examination successfully as per ORDINANCE-31.

10. ATTENDANCE REQUIREMENT :

A candidate should have at least 85% attendance in Theory and Practical separately. In exceptional cases it may be relaxed as admissible under applicable Ordinances.

11. GENERAL INSTRUCTIONS & SPECIFIC PROVISION :

For matters not covered in this Ordinance, general Rules of DEVI AHILYA VISHWAVIDYALAYA as applicable in Semester Examination shall apply. In other matters EXECUTIVE COUNCIL of DEVI AHILYA VISHWAVIDYALAYA shall be competent to take decision.

REGULATION FOR MASTER OF TECHNOLOGY (M.TECH.) - EXECUTIVE

1. Degree Title : Master of Technology (M.Tech.)-Executive
2. Name of Faculty : Faculty of Engineering Sciences
3. Subject* : M.Tech.(Executive) shall be offered in the following subjects:
 - (i) Computer Science
 - (ii) Data Science
 - (iii) Embedded Systems
 - (iv) Energy Management
 - (v) Instrumentation
3. Name of the School of Studies : Concerned School of Studies where the same programme is being offered under Regular mode.
4. Duration : Minimum: Two Years
Maximum: Four Years
As per Ordinance No. 14 applicable to UTDs.
5. Eligibility : The candidate should have at least 55% aggregate marks in B.E. / B.Tech./ M.Sc. in a relevant subject or any other equivalent degree from Devi Ahilya Vishwavidyalaya or any other University recognized by Devi Ahilya Vishwavidyalaya. Relaxation of 5% marks in eligibility for SC/ ST candidates. Relevant subject(s) shall be decided by the concerned School of Studies running the programme.

The candidates must have minimum two years of working experience after qualifying degree. The candidates have to submit a certificate from the employer on the prescribed Performa.
6. Age Limit : No Age Limit
7. Admission Procedure : As decided by Devi Ahilya Vishwavidyalaya from time to time.
8. Seats : 15
9. Fee : For the academic year 2018-19, per semester fee shall be as follows:
Academic Fee: Rs. 15,000
Development and Maintenance Fee: Rs. 12,500
Examination Fee: Rs. 2,500
Student Service Fee: Rs. 3,300
Caution Money (Refundable): Rs. 4,000 (Chargeable in the first

semester)

Devi Ahilya Vishwavidyalaya shall revise the fee whenever needed from the year 2019-20 onwards.

10. Teaching Learning Mode : The classes shall be conducted on weekends or in the morning / evening. Virtual classes can also be conducted. Projects / Assignments will be given in each semester.
11. Examination : There will be flexibility to take the courses in different semester so minimum requirement of credits in each semester shall not be applicable. Other provisions shall be as per Ordinance No. 14 applicable to UTDs.
12. Curriculum : As decided by the concerned Board of Studies from time to time. The curriculum will include theory, practicals, Massive Open Online Courses (MOOC), minor and major projects, and assignments. For MOOC provisions of Ordinance no 14 shall be applicable. MOOC can be taken from SWAYAM portal or any other portal, but choice of the courses and evaluation procedure shall be decided by the concerned School of Studies.
13. Eligibility for Degree : A student will be eligible for award of a degree when he/ she earns minimum required number of valid and virtual credits specified for the programme within maximum duration of the programme, but not before minimum duration of the programme.
- Minimum required valid credits = 80
Minimum required virtual credits = 16
14. Attendance Requirement : Requirement of attendance will be as per University Ordinance governing the Examinations (No. 6). In general attendance of atleast seventy-five percent of lectures and practicals separately will be required in each course to sit in the semester end examination.
- For special reasons such as prolonged illness deficiency in percentage of attendance not exceeding fifteen percent of the total number of lectures delivered and practical/sessional held in each course may be condoned by the Vice Chancellor.
15. General Instructions and Specific Provision : For matters not covered in this Regulation, General Rules of Devi Ahilya Vishwavidyalaya as applicable in Semester Examination shall apply. In other matters Executive Council of Devi Ahilya Vishwavidyalaya shall be competent to take decision.
