- The teacher will have an option at the time of their initial appointment to the University Service either to elect to join the Employees Contributory Provident Fund Scheme (Scheme 'A') or pension and Gratuity Scheme (Scheme 'B'). The option exercised by the teacher shall be final and binding. The option should be exercised in quadruplicate in the enclosed form within one month from the date of joining the post.
- 7/ They will have to submit a certificate of health and Physical fitness from a Government Medical Officer (not below the rank of Assistant Surgeon) at the time of joining or within seven days thereafter positively.
- 8/ They should report themselves for duty to the respective Head of the University School of Studies or Kulapati as the case may be, as soon as possible but not later than 22/1/2000.
- 9/ Persons coming from Govt. Deptts/Institutions should bring relieving letter from their present employer and should submit the same at the time of joining. In the absence of this document/certificate they will not be permitted to join the post.
