## **ADMISSION RULES AND INSTRUCTIONS**

1. The candidate is advised to apply for admission only if he/she fulfils the eligibility requirements.
2. **The onus of checking appropriate eligibility lies with the candidate.** Candidate must read and understand the details given in the guidelines available on the web site <http://www.dauniv.ac.in> carefully before filling the application form.
3. Check the form thoroughly before online payment, unpaid form will not be accepted in any case.
4. The Online application fee (non-refundable) is Rs.750/- (Rs. 400/- for SC/ST candidates of M.P. domicile). In addition to the application fee a portal fee, Rs.50/- will also be applicable. Candidate can pay fee online through MP-Online authorized KIOSK in MP or through any ATM cum Debit Card/ Credit Card or Net Banking from anywhere. If your amount is deducted and receipt is not generated, pay the fee again, as previous amount will be reverted automatically into your card or bank account. For more details on this issue call help line no. **0755-4019401 to 406** (six lines).
5. Eligibility for D. Pharm. Admission: **Pass in 10+2 examination (science academic stream) with Physics, Chemistry and Biology or Mathematics**
6. Number of Vacant seats: **27**
7. The last date of application form is **15<sup>th</sup> November, 2022.**
8. Procedure of admission: Admission shall be made on a merit list developed on the basis of 12<sup>th</sup> Percentage/grade point. The merit list and counselling schedule will be uploaded only on **www.dauniv.ac.in**  
  
In case of tie in percentage/marks, applicant having higher marks in biology/mathematics will be kept at higher rank. In case of tie of marks in biology/mathematics too, then applicant having higher marks in physics will be kept at higher rank. In case of tie of marks in physics too, then applicant having higher marks in chemistry will be kept at higher rank. In case of tie of marks in chemistry too, applicant with higher age will be kept at higher rank. In case of tie in age too, then according to English alphabet merit will be decided.
9. The tentative date of offline counseling is **18<sup>th</sup> November,2022.** The venue of counselling is School of Pharmacy, Devi Ahilya Vishwavidyalaya, Takshshila Campus, Khandwa Road (Ring Road), Indore-452001.
10. No written communication will be provided regarding counseling; Applicants are advised to keep-on visiting **www.dauniv.ac.in** for up-dation regarding counseling schedule and venue.

- 11.** Admission shall be offered after the document verification on the day of counseling. The information provided by the applicant in the application form will be verified at the time of counseling from the original documents by the authorities of University. If the applicant is found to have given incorrect/ false information at any point of time or to have omitted any relevant information at the time of completion of the application form, the applicant shall be disqualified from admission. Applicant's admission shall be treated as cancelled without giving any prior notice.
- 12.** The name of the applicant must be the same as given in the mark sheet of the qualifying examination of the Board. Competent authorities should certify the discrepancies in the names of mark/grade sheets, if any.
- 13.** Applicant is advised to mark/write correctly his/her category to claim the benefit. Change of category shall not be accepted thereafter.
- 14.** The candidates who fail to indicate the appropriate reservation category in the respective column of the application form will not have any claim for the reservation later on.
- 15.** In case any Board / Institute do not show percentage of marks in the mark/grade sheet, a certificate from the competent authority of the Board / Institute must be produced stating equivalent percentage of marks as well.
- 16.** The decision of the university authority in the matter of admission shall be final and binding. As per the directives of statutory bodies/ Government of Madhya Pradesh if any rules are modified and the same shall be binding on the applicants' admission.
- 17.** The reservation rules of government of Madhya Pradesh will be applicable for the admission for the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and Other Backward Classes (Non-creamy Layer), and Horizontal Reservation for female candidates.
  - 17.1 Seats reserved for SC/ST/OBC (Non-creamy layer) category will be offered to the SC/ST/ OBC (Non-creamy layer) candidates of Madhya Pradesh domicile only. SC/ST/ OBC (Non-creamy layer) candidates from other states and the candidates from other reserved categories from any state will be treated under unreserved category.
  - 17.2 SC/ST/OBC (Non-creamy layer) candidates have to produce valid category certificate and M.P. domicile certificate issued by competent authorities at the time of document verification.
  - 17.3 Reservation for Economical weaker section (EWS) candidates of Madhya Pradesh is as per rule of government of Madhya Pradesh.

18. **Non-eligibility for Admission:**

18.1 An applicant convicted by the court of law in India or outside or one against whom cases are being tried in the court/s or challan has been presented or has verifiable allegations against him/her concerning misbehavior/ beating of students/ officers/ employees or a person against whom disciplinary action has been taken by competent authority.

18.2 A full-time government employee/non-government employee cannot take admission in programme run during working hours.

19. **Fee Refund Policy:** The entire fee including all charges will be refunded on account of cancellation/withdrawal of admission up to 31<sup>st</sup> October 2022. Thereafter, on account of cancellation/withdrawal of admission up to 31<sup>st</sup> December 2022, entire fee collected will be refunded after deduction of Rs. 1000/- as a processing fee. Only caution money will be refunded on account of cancellation/withdrawal of admission after 31<sup>st</sup> December 2022.

20. Limited hostel accommodation is available within the campus of the university having four boys' hostels and five girls' hostels. For hostel accommodation admitted candidates are required to contact Chief Warden, Hostels, DAVV, Indore. Students staying in hostel are not allowed to work outside in part/full time.

21. All admitted students, who are not enrolled with the University, would be required to enroll themselves as per University rules.

22. Any legal dispute regarding admission is subject to Indore jurisdiction.

23. The fee structure is as follows:

1. Caution Money (Refundable) Rs. 4,000/- and Alumni Fee (Non-refundable) Rs. 500/- (one time) will be charged extra in the first year.
2. Hostel fee and Central Library Fee will be extra.
3. University has full rights to amend the Fee structure from time to time. Any such changes will also be applicable to admitted students for the session 2022-23.



24. The following documents will be required at the time of counseling:

1. Copy of application form submitted to MP-ONLINE.
2. Demand Draft of Rs. 10,000 in favor of “**Registrar (Self-finance) other, DAVV payable at Indore.**

The remaining fee will have to be deposited within the notified period thorough online mode (<https://davv.mponline.gov.in>). If a candidate fails to deposit fee within the notified period, his/her admission will be treated as cancelled and the seat will be offered to other candidate as per the order of merit and choice of the candidate.
