**Memorandum Of Understanding  
Between  
Dr. B.R. Ambedkar National Law University, Sonapat  
&  
Devi Ahilya University, Indore**

Dr. Ambedkar National Law University situated at Sonapat (Haryana) and Devi Ahilya University, Indore (Madhya Pradesh) wish to foster cooperation in education and research and to facilitate cultural exchange. Through this Memorandum of Understanding, the Universities affirm their commitment to cooperation between institutions.

1. The purpose of this Memorandum of Understanding is to promote and to facilitate an international and multilateral exchange between the two Institutions, and more particularly:
  - i. the mobility of their students, faculty members and staff between their two Universities; and
  - ii. the development of teaching and research activities between the two Universities.
2. This Memorandum of Understanding sets out the general principles governing the relationship of the two Universities. It will be completed by Protocols which shall apply to specific areas.

3. The Universities will explore the possibility of establishing Protocols in the following areas:

- i. the exchange of faculty members;
- ii. the exchange of students;
- iii. joint research projects and programs;
- iv. the exchange of of teaching materials and resources, including the on-line digital library accessibility;
- v. assistance in finding internships for exchange students;
- vi. cooperation in the development of joint teaching methods and projects;
- vii. assistance in organizing visits to companies and international institutions; and
- viii. other areas that may be mutually agreed upon.

The precise form of cooperation will be determined as the Universities set out in each Protocol.

4. Pursuant to this Memorandum of Understanding, the Institutions will facilitate contact between their researchers.
5. Upon the agreement of both Universities, this Memorandum of Understanding can be extended to include other existing partner institutions, so that an effective and comprehensive network of cooperating institutions may be formed.
6. Each University shall name one academic official who shall be responsible for the administration and facilitation of the Memorandum of Understanding and who shall be the person of record for official communication pertaining to the Memorandum of Understanding.

8. The partners in this Memorandum of Understanding will consult each other as often as necessary, and at least once a year, in order to evaluate their cooperation. Any modification to the present Memorandum of Understanding must be consented to by both institutions.
9. Details of this Memorandum of Understanding may be altered as a result of the experience acquired by both institutions and developments in their respective course programs.
10. This Memorandum of Understanding, as well as any Protocol made pursuant to it, is not a contract and does not create any rights or obligations including financial liability.
11. The confidentiality of both the parties shall be maintained.
