CDOE applied to DEB-UGC for recognition of Open and Distance Learning (ODL) and Online (OL) Programs from 2020-21 (Academic session beginning January, 2021 and onwards) in October 2020. Application was submitted for total 06 programs (PG:4, UG:2):

1. Master of Business Administration (Marketing, Finance, Human Resource)
2. Master of Business Administration (Energy Management)
3. Master of Arts (Sociology)
4. Master of Arts (Economics)
5. Bachelor of Arts (General)
6. Bachelor of Commerce (General)

DEB-UGC pointed out deficiencies mainly of faculty for the programs and so further rejected the application due to non-compliance.

Now, again DEB-UGC invited application from eligible HEIs for recognition to offer programs under open and distance learning (ODL) mode and/or online (OL) mode from academic year 2022-23, academic session beginning Sep-2022 (revised from July-Aug, 2022) and onwards (Call from DEB-UGC enclosed). The last date of submission of application is 31-05-2022.

CDOE intends to apply for all above programs and 01 additional program MCA (2Yrs) in ODL and OL Mode both.

Submitted for the approval of following:

1. Application may be submitted to DEB-UGC for only ODL Mode for - Master of Business Administration (Marketing, Finance, Human Resource), Master of Business Administration (Energy Management), Master of Arts (Sociology), Master of Arts (Economics), Bachelor of Arts (General) and Bachelor of Commerce (General) and ODL and OL Mode both for MCA (2Yrs).
2. Administrative approvals regarding Content Design Committee, Program Coordinators, fees fixation for above 06 programs (PG:4, UG:2) taken earlier in October 2020 stands valid (as no change is proposed) for current application to DEB-UGC.
3. Administrative approvals regarding Content Design Committee, Program Coordinators, fees fixation and Ordinances for MCA program shall be taken separately.
