This Extension to the Agreement dtd 16.01.12 and Addendum to the Agreement dtd 11.10.17 is made on this 21st day of May, 2018.


BETWEEN


Devi Ahilya Vishwavidyalaya, Indore a statutory University of the State Government of Madhya Pradesh having its Head Office at Indore acting through its Registrar (hereinafter called "DAVV" which expression shall, unless repugnant to the context or meaning thereof, include its successors and assigns) of the **FIRST PARTY**,

AND

NTPC Foundation, a registered Public Charitable Trust established by NTPC Limited, having its registered office at NTPC Bhawan, SCOPE Complex, 7 Institutional area, Lodhi Road, New Delhi-110003 acting through its General Manager, NTPC Foundation (hereinafter called "NTPC Foundation" which expression shall, unless repugnant to the context or meaning thereof, include its successors and assigns) of the **SECOND PARTY**.

These two parties shall be independently referred to as 'Party' and collectively as 'Parties'





Whereas the Parties executed an "Agreement" dated 16.01.2012, for setting and running up Information & Communication Technology Centre at Devi Ahilya Vishwavidyalaya (DAVV), Indore and the Addendum to the Agreement dated 16.01.2012 made on 11.10.2017 and is valid upto 01.04.2018.

WHEREAS the said agreement expired on 01.04.2018. In accordance of the said agreement, parties have now agreed in writing to extend the validity of the Agreement for an additional term of 5 years commencing from 2nd April 2018 and will be valid till 1st April 2023.

"The Agreement shall come into force as soon as it is signed for all purposes and intents shall remain in force for a period of 5 years / academic sessions from the date of commencement of the ICT Centre."

The Agreement dated 16.01.2012 and the Addendum to the Agreement dated 11.10.2017 will form an integral part of this Agreement.

Save and except the Agreement as agreed herein, the other terms and conditions of the Agreement dated 16.01.2012 and the Addendum to the Agreement dated 11.10.2017 shall remain unchanged.

Wherefore the parties hereby have agreed as under and sign the same on this 21st day of May, 2018 at NOIDA/DAVV, Indore.
