**Academic Audit Report (2014-2018)**

This report indicates the Academic Audit status of School of Pharmacy, wherein the audit for conducted for every academic year, viz. 2014-15, 2015-16, 2016-17 and 2017-18. The audit was conducted on following six criteria:

- I. Curriculum Development
- II. Teaching and Learning Process
- III. Evaluation Process
- IV. Research Activities
- V. Infrastructure & Learning Process
- VI. Co-curricular Activities

The salient points under each criterion are:

- I. Curriculum Development:** The process of implementation of Choice-Based Credit System initiated in 2014-15 with suggestions to incorporate Pharmacy under Ordinance 31 of University. CBCS was implemented in 2015-16 and B.Pharm. and M.Pharm. courses' scheme, syllabi and regulations were revised. The new syllabus was in line with student and industry needs. But in 2016-17, Pharmacy Council of India, New Delhi notified the regulations of Credit Based Semester System for B.Pharm. and M.Pharm. course. Subsequently, PCI Regulations were adopted and implemented in 2016-17. In 2017-18, syllabus of Ph.D. course work was revised as per UGC Regulations 2016 for Ph.D. and Research Methodology in Pharmacy was introduced as a new subject.
- II. Teaching and Learning Process:** Teaching/ learning process is made on time with academic calendar display and is disseminated to all teachers, students and staff timely with proper follow up and evaluation. Innovative teaching learning methods in practice with syllabi updation is done with timely completion. Use of ICT methods is widely used by teachers. Experts from industry and academics are invited for guest lectures.
- III. Evaluation Process:** Evaluation process is done on transparent and fair basis and is communicated to students on time. Grievance handling mechanism is maintained. The students are shown valued answer books of semester exam under CBCS.
- IV. Research Activities:** Four faculty members were granted seed money projects by University in 2014-15. Golden Jubilee Fellowship was awarded to one of the Ph.D. Scholar in 2014-15. One of the Ph.D scholars with DST Inspire Fellowship was admitted to Ph.D

course work in 2014-15. In 2016-17, DST WOS-A Fellowship was awarded to Dr. Sunanda Panda. Faculty received certificate of Appreciation for highest citations by University in the year 2016-17 and 2017-18. The faculty of School of Pharmacy published good quality research papers in national and international journals of repute. They also presented their quality research in national and international conferences and seminars. The faculty also received various awards in these conferences/seminars for their paper presentations. Total ten scholars have been awarded Ph.D. from 2014-2018 and approximately twenty nine scholars are registered for Ph.D. in Pharmacy. The faculty of the School is also involved in inter-disciplinary research which is evident from the joint publications of faculty of School of Pharmacy with School of Life Sciences, School of Biotechnology, IIT-Indore. School of Pharmacy also conducted National Workshop on "Molecular Biology Experiments" under University-Industry Linkage on 6<sup>th</sup>-7<sup>th</sup> October 2016 and National Seminar under Industry Institute Interaction on "Basic and Applied Immunology: An Industrial Perspective" on 27<sup>th</sup>-28<sup>th</sup> January 2017. School also applied for CPEPA (Biological Sciences) and UGC-SAP-DRS Phase I in 2014-15 and 2016-17 respectively.

- V. Infrastructure & Learning Process:** Classrooms are ICT enabled, labs are well equipped. Library, computer labs, Divyang friendly infrastructure and wash rooms are well maintained. Wi-Fi was installed in 2017-18. New equipments like ELISA Plate Reader, Auto-Analyzer, Refrigerated centrifuge, Stability chamber, Deep Freezer were procured.
- VI. Co-curricular Activities:** Students are encouraged for academic and cultural and co-curricular activities. One of the M.Pharm. student, Rahul Dixit participated in Republic Day Parade at New Delhi on 26<sup>th</sup> January 2017. Students of B.Pharm. and M.Pharm. (Shikha Sharma, Mohd. Shadab Qureshi and Aniket Sharma) secured third prizes in 13<sup>th</sup> and 14<sup>th</sup> National Youth Parliament Competition organized by Ministry of Parliamentary Affairs, Govt. of India in the year 2017-18 and 2018-19. Mr. Kapish Kapoor, student of B.Pharm. won second prize in the Inter-University Zonal Youth Festival held in the year 2016-17. Students of School of Pharmacy participated in various activities of Sphoorti 2015 and 2018 and secured prizes in inter-departmental group dance and skit competitions.

**All these activities made possible the 31<sup>st</sup> and 45<sup>th</sup> Ranking of School of Pharmacy in Pharmacy Discipline in NIRF India Ranking 2017 and 2018 respectively.**
