Sub: Extension of approval of affiliation of School of Law, Devi Ahilya Vishwavidyalaya, Indore, Madhya Pradesh for imparting five year BA LLB law course.

Sir,

The Bar Council of India at its meeting held on 23rd August, 2014 considered the inspection report of the above mentioned college. After consideration the Council decided as follows:

The Bar Council of India considered the inspection report submitted by the inspection team. After consideration, the Council is of the view that School of Law, Devi Ahilya Vishwavidyaya, Indore be granted extension of approval of affiliation for imparting five year BA. LLB law course with an intake of one section of 60 students on temporary basis for the academic years 2011-2012, 2012-2013, 2013-2014 and further for two years i. e for the academic years 2014-15 and 2015-2016 subject to the following conditions:-

- The Department is directed to establish the Legal Aid Centre as per Clause-11, Schedule-III of Rule-11 of the Part-IV of the Legal Education Rules - 2008.
- The Department should ensure the payment of salary to teachers as per Rules ?2 schedule III, Part IV of BCI Rules.
- The institution is directed to upgrade the library by investing minimum Rs.50,000/- per year.
- Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.

5. Department shall observe and follow the legal education rules 2008.

Institution should submit affidavit in compliance to the above conditions within six weeks.

College authorities are also required to apply to the Bar Council of India for further extension of approval six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2015 failing which a late fee will be charged.

This is for your information and necessary action.
